1. Name of Society

The name of society is Ved Education Society, Hisar.

2. Date of Establishment

Ved Education Society Hisar was established on 30.3.1986.

3. Location

- 1) The Registered office of the Ved Educational Society will be located at Hisar. (In the Institution Building)
- ii) Ved Education Society is a Non-political Social Organisation.

AIMS AND OBJECTS :

1. To construct school and other educational institution and to impart education to the students of all castes and creed in accordance with the instructions issued by the Education Department of Government of Haryana.
2. To work to remove illiteracy from the Society.
3. To help the poor students in getting education and provide them scholarships and for their future studies.
4. To arrange the proper place for the Institution building either on lease or purchase from Government or Municipal Committee or from Hisar Improvement Trust or other person.
5. To educate student to be good citizens and patriot of their Motherland and popularize education in rural area.
6. To publicise literature and pamphlets relating to education.
7. To arrange function from time to time for the fulfilment of the above aims and objects.

8. Members of Education Society shall not be on salary roll of the Ved Education Society for any office of the Education Society which means no remuneration shall be paid to any member, except the repayment of put of pocket and interest of money lent or rent of the premises demises to the Education Society.
9. All its funds dervied in the name Ved Education Society shall solely be utilised for promoting its aims object.
10. To undertake such activities and programmes as are necessary for the fulfilment of the above aims and objectives.
11. At the time of dissolution of the Ved Education Society after satisfying its all debts and liabilities, any assets whatever the same shall not be paid or distributed among the members of the society but shall be transferred to some other society having its similar objects as decided by the Executive body, subject to the acceptance of one founder member.

CONSTITUTION RULES & REGULATIONS OF VED EDUCATION SOCIETY HISAR.

1. **Titles :** These rules and regulation may be called constitution, Rules and Regulations of "Ved Education Society, Hisar.
2. **Year** The year will be financial year commencing from 1st April of every year and end on 31st March of next year.
3. **Definition** The Ved Education Society is a body set up under Societies Registration Act XXI of 1860 and amended by Punjab Amendend Act 1957 with the aims and objects as laid down in the Memorandum of the Association.
4. **Composition**
- a) Membership of all persons who have attained the age of 21 year and above shall of eligible for membership irrespective of race nationality, sex, religious, education, domicile, social origion property status or past activities with the exception of Mad-in sane or criminal and convicted by the court of law. The recommendation of the one founder member is essential for new membership.

b) Categories of Membership :

1) Founder Members :

Members of this Memorandum, out of the signature Sh. Ashok Sharma, Sh. Hari Krishan Sharma shall designated as founder members.

Individuals who pay a lump sum of Rs.101/- with the admission fees of Rs.5/- will be enrolled as life members.

iii) Ordinary Member

Individuals who pay a yearly subscription of Rs.11/- with the admission fee of Rs.2/- will be classified as Ordinary Member.

iv) Honorary Member

Person of distinction who has special aptitude for social services and of experiences may be invited to become the member without paying any subscription what-so-ever.

v) Institutional Member.

Representative of any other organisation Association, society interest in social welfare programmes and fulfill like aims and objects may be nominated as the member without any subscription.

c) Duration of Memberships

i)

For all above mentioned categories (i) to (v) generally be for a period of one year but it could be extended after the approval of the Executive body except founder members and life members & Manager.

ii)

A member ceases to be member if he or she resigns, becomes of unsound mind, insolvent or is convicted of criminal offence involving moral turpitude.

iii)

If a member fails to attend three consecutively meeting of society he shall cease to be a member.

iv)

The founder members remains as a permanent members till his death or resignation.

v)

A resignation of membership shall be addressed to President/Vice President/Secretary and shall not take effect until it is accepted by the President in consultation with Manager.

vi)

If a member is engaged in activities detrimental to the aims and object of the Ved Education Society shall have the right to terminate his membership.

Any vacancy in their membership shall be filled by the nomination by the Executive body, but willingness of one founder member is necessary.

d) General Body

i)

All the members of the Ved Education Society as defined in rule 4 above will have full right to attend the general meeting of the house. But their rights to vote will be strictly in accordance with rule 4(a), 4(b), VIII (d).

ii)

To pass the annual budget.

iii)

To approve the action of the Executive Body.

iv)

To select the office bearer of Executive Body.

v)

To amend constitution by majority of 2/3rd present member having voting rights. The Founder members have a veto power.

vi)

Any other business which would be considered necessary be a majority of member.

e) Meeting of General Body

The General Body will meet once in a year for which a notice specifying the agenda will be issued by the Secretary/Manager on advice of President well in advance giving period of one month notice to each member by post or in person.

f) Management and Administration :

- 1) There will be Executive Body of the members to ensure and fulfil, the aims and objects of the Ved Education Society Hisar.
- ii) The Executive Body will consists of atleast Thirteen members.
- iii) The Executive body may nominate from its membership a body for its various programmes from time to time.
- iv) The Executive body will be responsible for the smooth running of the Institute.



g) Office Bearers :

- i) Collectively the members would elect Vice President 1 No., Joint Secretary 1 No., Chief Advisor 1 No., Advisor 2 No., Auditor 1 No., Educationist 1 No., Member 1 No., Ex-officio Member 1 No., Teacher representative 1 No. as office bearers by the majority of vote after one year in the month of April not later than mid of August, during the life time, of founder members Sh. Ashok Sharma will be the president and Sh. Hari Krishan Sharma will be the Secretary and Manager.
After there will be election of President, Secretary and Manager.
The Head of Institution will also remain members of the society. Any member of the society can hold two posts of the office bearer.

H) Tenure of office Bearers

The terms of the office of the Executive Body shall be normally one year or till such time new body is framed under its

5. Functions

a) Functions of Executive Body :

The Executive Body shall meet atleast ~~at least~~ three months to prepare the programme for the development of Institution to trade raise public contribution both in cash and in kind, to prepare the budget and its resources and other things for achieving the aims and objects of Ved Education Society and issue instructions to the concerned from time to time. Further more the body would seek all possible guidance, assistance and cooperation from sister organisation Government and Semi Govt. department to fulfil aims and objects.

b) Function of the Office Bearers :

i) President : The President of the Ved Education Society Hisar shall preside over and conduct the meeting of the Society. He can veto the decision of the society.

ii) Vice-President: The Vice-President will preside over the meeting when the President is not available.

- iii) Secretary : The Secretary will be responsible for smooth running of the programme and would be responsible for all the office work and to ensure fullest co-operation, assistance and guidance from various agencies.
- iv) Joint Secretary: The Joint Secretary will work as a Secretary in the absence of Secretary.
- v) Manager The Manager shall ensure proper maintenance and audit of a/c required under the rules prescribed by the Executive Body. The Manager will have financial & general control of the institution.
- vi) Chief Advisor The Chief Advisor will assist the Secretary for smooth working of the society.
- vii) Advisors The Advisors will assist the Chief Advisor and Society.
- viii) Auditor Auditor will audit the account of the society. He will give his report to the president of the Society directly.
- ix) Educationist: Educationist will be the Member of Managing Committee and also teacher selection committee.
- x) Member The member is authorised to advised the Secretary/Manager and are authorised to cast the votes for election.
- xi) Head of the Institution/ (Ex-Officio Member), The Head of the Institution is responsible for the smooth running of Institution.
- xii) Teacher Representative In addition to the teaching duty he/she assist the Head of the Institution and society.

6. MEETING :

a) Ordinary Meetings :

- i) The Executive body shall meet after every 3 months.
- ii) At least one month notice for the meeting shall be given by the Secretary.
- iii) One third of the members present in person shall constitute the quorum.
- iv) A meeting which was previously not held for want quorum, shall require not quorum at the next meeting.
- v) All meetings shall be convened by the president and shall be held as such places where facilities of the programmes available.
- vi) If the president/vice-president is not available for the meeting the Secretary can preside over the meeting.



b) Extra-Ordinary Meetings :

The Extra ordinary meeting can be conveyed by the President/Secretary at any time at 30 days notice.

7. Finance :

- i) The executive body shall submit its budget estimate yearwise for its programmes every year in the month of February. However, a supplementary budget estimate, if any can be considered as and when necessary.
- ii) All receipts and expenditures will be maintained under the heads under the Name of Ved Education Society, Hisar.
- iii) Yearly statement shall be presented to the Executive Body for his approval.

- iv) The financial year of Ved Education Society would be 1st April to 31st March of every year.
- v) The President/Vice-president/Secretary shall have the power to sanction subject to the budget provisions.
- vi) The Executive body shall maintain its accounts in the name of Ved Education Society in any schedule Bank. All funds shall paid into the Bank. Account and shall be withdrawn over by joint signatures of President & Secretary.
- vii) The ~~receipts~~ and expenditure accounts shall be maintained properly in the describe manner of Budget.
- viii) The audited account together with the auditor's report appointed by the Executive body be presented before the Executive Body for its approval.

8. General

- a) The income and property of the ved Education Society shall be applied solely towards the promotion of the objects of the society as set fourth in the Memorandum of Association and no portion thereof shall paid or transferred directly or indirectly by way of profit, to the members of the body.
- b) No member of the Executive Body shall be appointed to the any salaried office of the society of any office of the paid by fees, that no remuneration shall be given by the society to any member such Executive Body except the repayment of out of pocket and interest of money lent or rent of the premises demises of the Education Society.

- d) The advising committee of other institutional members and social worker will be set up for advising the society of Institution. The members of this body are not entitled to franchise votes for election of society.
- e) If upon the winding up or dissolution of the society there remains after satisfaction of all its debts and liabilities any property whatsoever the same shall not be paid to or distributed among the members of Executive Body but shall be given or transferred to some other institution having object similar to the objects of the society to be determined by the Members of the Education Society at or before the time of dissolution, subjects to the acceptance of founder members.

9. Funds :

- i) Income from membership fee.
- ii) Grant from Government/Semi Government.
- iii) Loan from Financial Institution or Scheduled Bank.
- iv) Donation from individuals/group of persons and various institutions.
- v) From any other source just as education department Haryana etc.

10. Amendments :

- i) The Executive body shall have the power to make if necessary such rules and regulation by way for conducting its business and programme for the smooth running for its aim and object.

ii)

These rules and regulations may be altered or amended and additions may be made at any time by a two third majority of the present members of the Executive body and entitled to vote ; But at the same time the president is also empowered for such alteration with the consent of Secretary subject to the emergency which require the approval of Executive Body within its 30 days.

There is no ban on the member or office bearers for doing any work for their livelihood.


